



Our approach to ESG is a core commitment. Not only because it allows us to expand our business sustainably, but because it is the right thing to do for our stakeholders and all of society.

Environment

We continue to accelerate our initiatives to address environmental issues, such as responding to climate change:

- Nature-based carbon sequestration

 Through Mitsui Bussan Woodchip
 Oceania and Outback Carbon, and
 investments such as New Forests,
 and Climate Friendly, we continue to
 accelerate GHG reduction activities
 such as plantation forestry,
 environmental planting, and
 regeneration of native vegetation.
- Hydrogen The Yuri Project in partnership with Engie, aims to contribute to accelerating the upscaling of the hydrogen industry in Australia by supplying green hydrogen to existing ammonia plants in Western Australia.
- Carbon capture & storage (CCS) We are participating in a feasibility study into CCS as well as low-carbon ammonia production with CCS in Western Australia in partnership with reputable Australian and Japanese organisations.

Social

We know the impact that we can have on Australian society and local communities and understand the importance of giving back. We contribute to community development through various activities:

- Mitsui Educational Foundation was established in 1971, with an aim to develop mutual understanding and friendship between Australia and Japan. Mitsui invites selected Australian students to take part in a three-week study tour of Japan, providing opportunities to learn about Japanese culture, society, business, and people.
- Mitsui Iron Ore Development supports the Polly Farmer
 Foundation with funding to an Alumni Program, which provides support and encourages Indigenous & Torres Strait Islander people to continue their studies after school, or enter traineeships and increase employment opportunities.

Governance

We continuously work on strengthening our governance and compliance to ensure we met and exceed all stakeholder expectations. Our initiatives include:

- Tax Transparency Report We have adopted the Voluntary Tax Transparency Code, and our report reflects our commitment to providing accessible and clear information about our businesses and our approach to taxation.
- Supply Chain Management Our Sustainable Procurement Policy sets out the standards of practice which we require our suppliers to embody in their operations and supply chains. The Policy aims for legal compliance, no modern slavery, protection of human rights, sound labour practice, environmental protection, and animal welfare.
